S. AND IS THOROUGHLY FAMILIAR WITH HANDLING INVESTIGATIONS IN MEXICO. THIS AROUSED AMBASSADORIAL IRE.

THIS IS FOR BUREAU INFORMATION. LEGAT FEELS NO USEFUL PURPOSE WOULD BE SERVED BY HAVING BUREAU REPRESENTATIVE COME HERE. IF STATE PASSES AMBASSADOR'S REQUEST TO BUREAU, IT IS SUGGESTED REQUEST BE TACTFULLY DENIED WITHOUT LEGAT RECOMMENDATIONS BEING MENTIONED TO STATE.

IT IS DESIRED TO EMPHASIZE THAT OUR RELATIONS WITH AMBASSADOR

ARE EXCELLENT AND HE IS MOST OUTSTANDING AMBASSADOR WITH WHOM LEGAT
