Oswald paid box rental of \$1.00 on June 3, 1963 for the period June 3, 1963 through June 30, 1963. Lee H. Oswald paid \$3.00 box rental on June 25, 1963 for the quarter beginning July 1, 1963. Both payments were nade at the Lafayette Square Substation for the rental of Post Office Box 30061.
