

On November 26, 1963, material of various types which had been recovered by the Dallas Police Department from the residence of LEE HARVEY OSVALD at 1026 Beckley, Dallas, Texas, and from the home of Mrs. MICHAEL R. (RUTH) PAINE, 2515 West 5th Street, Irving, Texas, where OSWALD's wife resided and where he periodically visited, was turned over to SA's KENNETH C. HOWE, JAMES P. HOSTY, JR., and WARREN C. DE HRUEYS of the Federal Bureau of Investigation.

The above material was brought by the above agents, Captoin J. M. ENGLISH of the Dallas Police Department, and H. W. HILL, an employee of the Dallas Police Department Property Room, to the Dallas FBI Office.

The above material at the Dallas Office of the FBI was photographed and inventoried and items pertinent to the investigation subsequently were personally transported by air to FBI headquarters in Washington, D.C., by SA DE BRUEYS, along with a complete copy of the inventory.

A copy of the inventory of the above material is being maintained in the Dallas file on LEE HARVEY OSWALD. This inventory is marked to indicate those it tems not believed pertinent to the investigation at this time and these items are being retained in the Dallas Office.
