The following investigation was conducted by EA ROBERT L. CHAPMAN:

### AT LAREDO, TEXAS

On December 3, 1963, AUGUST O. HEIR, Assistant Principal, Martin High School, the only public high school in Laredo, Texas, was contacted to locate an ALTCIA SERTHA FAMOS who departed Mexico on October 3, 1963, by unknown means and who was listed in the Mexican Insignation records as being 16 years of age. /Mr. HEIN advised that he had two girls by the name of ALCIA RAMOS in Hartin High School and both of them were in school on October 2 and 3, 1963. Mr. HEIN stated he questioned both girls and neither had been to Monterrey, Suevo Leon, Hexico, which was the city that Mexican Insignation records indicated that RAMOS he disitted.

The Maredo Telephone and City Directories contain a lint of approximately 50 families by the name of RAMOS residing in Laredo, Texas.

No ALICIA RAMOS could be located in the nolding Institute or St. Augustine High Schools, the only other high schools in Laredo, Texas.

The following investigation was conducted by Si DOW R. ROSE:

#### AT SAN ANTONIO, TEXAS

Current San Antonio telephone and city directories were examined and found to contain no names identifiable with C. ENVING (FNU) NIETO, R. GOMEZ, or E. GUTTERREZ.

On December 17, 1963, records of the Retail Merchants Association were examined by IC JOHN C. SMITH and found to contain no records identifiable with the above individuals.

On December 11, 1963, JOE MENDRICKS, Detachment Commander, Office of Special Investigations, Lackland Air Force Base, advised SA DON R. ROSE that he had referred to appropriate records at Lackland Air Force Base and ascertained that no R. GOMEZ arrived at that base on Cotober 3, 1963, or anywhere near this date. He said there is an R. GOMEZ presently stationed at Lackland Air Force Base whom he identified as RAUL N. GOMEZ but explained that this GOMEZ was a basic trainee who arrived at Lackland Air Force Base on November 6, 1963. According to him there is no other R. GOMEZ stationed at that base.

Mr. KENDRICKS further advised that he could find no record concerning a (FNU) NIETO.

On December 12, 1963, Mr. R. JAMES CUNNINGHAM, Joint Airlines Military Ticket Office (JAMTO), Lackland Air Force Base, advised after referring to appropriate records that Airman Third Class REYMALDO GOMEZ was assigned to Lackland Air Force Base during the poriod in question but had been transferred to Gettysburg Air Force Station, Gettysburg, South Dakota, recently. He said that REYMALDO GOMEZ' residence is listed as Eruni, Texas, which is close to Laredo, Texas, and he quite probably is the R. GOMEZ that was on Trans-Texas Airway Flight 290 from Laredo, Texas, to San Antonio, Texas, on October 3, 1963.

ME. CUNNINGHAM also made known that he had determined that two NIEROs had been assigned to Lackland Air Force Base. He identified these individuals as DONALD E. NIETO who is presently in Officer's Training School, Median Base, in class G4H. Re identified the other NIETO as FRANCISCO A. NIETO who recently was transferred to the 340th Bomber Wing, Bergstrom Air Force Base. Texas.

om Docember 12, 1963, Officer Candidate #9.7ALD E. NIETO, Class 64E, Officer's Training School, Medina Base, advised SA DON R. ROSE that he was not in the Air Force as of October 3, 1963, and was not on Flight 290 of Trans-Texas Airways, flight from Laredo, Toxas, to San Antonio, Toxas, on October 3, 1963. According to him he was in California on this date.

On December 19, 1963. \*\*REMEDISCO A. NIETO, 34oth Bomber Wing, Borgstrom Air Force Base, advised SA H. T. BURK that he entered the Air Force on September 13, 1963, as a recruit and finished his basic training at Lackland Air Force Base on Noverber 13, 1963. He said he has never been to Laredo, Texas, and was not on Flight 290 of Trans-Texas Airways from Laredo, Texas, to San Antonio, Toxas, on October 3, 1963.

On December 20, 1963, FRANK M. DRAIN, 918 Manor Drive, San Antonio, Texas, advised SA DON R. ROSE that he has taken a number of flights on Trans-Toxas Airlines from Laredo, Texas, to San Antonio, and he recalls the flight from Laredo to San Antonio on October 3, 1963. He said that he does not recall seeing anyone on this flight resembling the photograph of LEE IMRNEY OSWALD.

On December 20, 1963, Mr. A. RAFFALLE, Base Locator, Kelly Air Force Base, Texas, advised SA DON R. ROSE that the records of his office contain no mention of any millitæry officer or enlisted man by the name of NIETO. He added that his records contain the name of those individuals who have been transferred from that base since October 3, 1963.

Mr. RAFFAELE pointed out that had an Air Force member been assigned to Kelly Air Force Base on temperary duty (TDY) he would have no record of this individual.

On December 20, 1963, Airman First Class RICHARD F. GAFFNEY, Base Locator, Eandelph Air Force Base, Texas, advised that his records make no mention of any individual by the name of THETO.

On December 20, 1963, Airman First Class JAMES A. CURILY, Base Locator, proofs Air Force Base, Toxas, advised that his records make no mention of an individual by the name of NIETO.

Let DATNELLY, Assistant Chief of the Administrative Division, State Selective Service Headquarters, Austin Texas, prepared a memorandum concerning her recollection concerning a contact with LEE HARVEY OSWALD which memorandum rends as follows and which was prepared specifically for Saccial Arens H. T. DUNK:

"At your request, following is a resume of information the undersigned furnished to Mr. RONNIE BRIGGER, publisher of the "Texas Observer and representative of a Washington D.C., daily newspaper, on 17 December 1963.

"Mr. DUGGER called at this Headquarters at approximately 4:30 PM, 17 Dec 63; he showed me an identification can'd from the Department of Public Safety and stated he wished to obtain any 1 ormation 1 knew relative to a wist by LEE MARKEY CSNALD to this Headquarters. Defore 1 gave his any information, my supervisor Lt Col. William ECT SINCLAIR walked up to my desk and the two greated one another. Colonal SINCLAIR asked Mr. DUCGER to come on in to his office and Mr. DUCGER told him that as soon as he asked me a few questions he would come in

"Mr. DOGGER asked if I could furnish in detail everything in connection with the visit of the Hanvir Osvalb to this Headquarters and I advised him as follows On 24 Mov in (Sunday). it was announced over TV that at that tipe there was no definite record as to Mr GSWALD's whereabouts from may 1963 until the time of the assasination of President KENNEDY. I was at home at the time and I called Colonel BINCLAIL and advised him I was possitive this man had been to our office, approximately flor 8 weeks prior to that date (24 Nov 63). I could not recall any information that would make me positive about a specific date but that I was positive that it had been on a Wednesday. I have been having quite a bit of trouble with my back and

legs for quite sometime, and the only times I have gone to town during my lunch hour was on our pay days to cash a check -- we are paid on alternate Wednesdays. I was a few minutes late getting back to the office that day and Mr. OSWALD was waiting to see me when I got back. Mr. OSWALD stated that he' had just come from the Governor's office to try to straighten out his discharge from the Marine Corps, which had been under 'other than honorable conditions.' The Governor's office told him they did not have anything to do with such things but that maybe this office would be able to assist him. Mr. OSWALD stated that at the time he was given the discharge under 'other than honorable conditions' he was told that if he lived an upright life for the next two years, he could then make application to have the type of discharge changed to 'honorable.' He told me that he was having difficulty in obtaining a job, and holding a job, with that type discharge. Also, he said it was embarrassing to his family. I asked him where he was registered and he said he registered in Florida but that he was liwing in Ft. Worth at the present time. I checked our locator file for HARVEY OSWALD (the name he gave me), but did not check any of the other OSWALD cards for possible identification since I presumed he was correct and was registered in Florida. I did not find a card for HARVEY OSWALD. We do have a card for LEE HARVEY OSWALD. Mr. OSWALD did not remember whether he had given his address in Fort Worth (at time of separation from the Marine Corps) as place of entry into service or not. I advised him to check with our local boards in Fort Worth when he got back and maybe they would have a copy of his Report of Separation (DD Form 214).

"This Headquarters maintains sets of military regulations from the various armed forces which jointly concern the Selective

Service System. I checked these regulations in an attempt to bearn the exact procedure Br. OSWAID should follow in making application for a change in 'type' of discharge. I did not find the regulation covering this subject. I then gave Br. OSWAID a copy of an information shoet (B-1229) (copy attached) which lists the location of various types of military records, so that he could write direct and request the procedure for making the application for change in 'true' of discharge.

Mrs. DANNELLY forther related orally that she is of time belief at this time that the date on which LEE HARVEY CONTAIN contacted her was September 25, 1903.

Mes. DANNELL? advised that she cannot establish this date from any official record at the State Selective Service Headquarters due to the fact that no record was made at the time she interviewed OSVALD or at the time OSWALD called upon her. She advised that the date is established in the following manner. She advised that she brings her lunch to work each day and has lunch in the office with exception of the days on which she is paid which is every other Wednesday. She advised that on these so called pay days that she frequently goes to the bank for the purpose of withdrawing money from her account. She does not deposit her sal ay check in the bank due to the fact that these checks are natted direct to the bank and she is not required to make these deposits, the checks being mailed direct from the office. She does business at the Capital National Bank, Austin, Texas, and on the date in question she advised that she recalls coming back to work slightly after 1:00 p.m., perhaps at about 1:05 p.m., and on that date had been to the rair branch of the Capital National Bank, Austin, Texas, and cashed a check in the amount of \$100 and In addition she had had lunch elsewhere other than the office where she normally had lunch. She advised that there is a possibility that the date on which OSWALD was in Austin, Texas, could have been September 11, 1963, because from her cancelled checks which she personally carried to the Capital National Bank she had the bank employee look at all of her cancelled checks for the last six months and he picked out only three of those chacks that according to the bank stamp had been cashed inside the main Capital National Bank. The first of these checks, the more recent of them rather, was September 25, 1963; the second was September 11, 1963; and the third was July 31, 1983 Of these three checks Wrs. DANNELLY feels that the September 25, 1963, date is the more accurate date of the visit of GSWAID.

Mrs. DaiNELLY further pointed out that her other banking operations and withdrawals from the bank are done at the drive-in window of the Capital National Bank which is discitly across the street from the State Selective Service Headquarters on the south side of her building and 5

that she frequently did business at that drive-in window after normal banking hours and other checks cashed by her would bear a stamp indicating they were cashed at the drive-in window rather than at the main bank proper

A photograph of LEE HARVEY OSWALD was exhibited to Mrs. DANNELLY and she stated that in her opinion the photograph looks like the man who came to State Selective Service Headquarters on the day in question inquiring concerning the discharge mentioned above.

Mrs. DANNELLY advised that she recalls being at the Trek Cafe on South Congress Avenue, Austin Texas, on November 24, 1963, at which time she was engaged in conversation—ith a man who is employed as a printer for the Austin—aily paper and at that time this individual whose name is not known to her at this time advised her that he believed that he had seen LEE HARVEY OSWALD at the Trek Cafe sometime in the past. This man had seen OSWALD's photograph on television at that time and due to this conversation, Mrs. DARKELLY recalled her experience of having been contacted by the individual using the name of HARVEY OSWALD and recalled that the photograph seen on television remembled the individual who had contacted her using the name of HARVEY OSWALD.

Mrs. DANNELLY advised that the printer whom she tangaged in conversation at the Trek Cafe was a white male, age 15, of slender build, approximate 5' 6" to 3' 8", 125 to 140 pounds, and during the course of conversation had mentioned that he had been recently divorced and had a home in the country where he kept a considerable number of dogs. Mrs. DANNELLY advised that she had seen this printer in the Trek Cafe on inverous other occasions and knew him by sight but not by name.

Mrs. DANNELLY likewise recalled as best she could remember at this time Mr. RONNIE DUGGER is a friend of the son of the printer referred to above. She also recalls that a waitress at the Trek Cafe made some comment indicating that she was of the opinion that OSWALD had been in that cafe at one time or another. She seems to recall

that this waitress was named BOBBIE, last name unknown, and that she was a sister-in-law of one BILL COVINGTON, manager of the Trek Cafe.

Mr. LARRY TEMPLE, Administrative Assistant to the Governor of Texas, Capital Building, Austin, Texas, advised a thorough search of all the guest registers maintained in the Governor's Office in Austin, Texas, back for the last proceeding six months failed to reveal a registration for LIX YEARVEY OSWALD, or HARVEY OSWALD, or any other individual that can be possibly identical with LEE HARVEY OSWALD. He advised that as a general rule all individuals or guests coming to dr calling on the Governor or any of the Administrative Assistants to the Governor are required to sign these guest registers. He advised that there is no record of OSWALD having signed such a register.

TEMPLE further pointed out that any individual contacting the Governor's Office with respect to a matter concerning the military, for example a military discharge, would under normal conditions have been referred to him. TEMPLE, for handling and interview. He advised that he at no time recalls ever having contacted LEE HARVEY OSWALD concerning any matter either concerning a U. S. Marine Corps Discharge or any other type matter. He advised that a thorough search of all of the records and indices maintained in the Governor's Office failed to reveal any information whatsoever concerning LEE HARVEY OSWALD and has no record of any correspondence ever having been carried on between Governor's Office of Texas and LEE HARVEY OSWALD.

Mrs. LEE DANNELLY, Assistant Chief of the Administrative Division, State Selective Service Headquarters, Austin, Texas, advised the State Selective Service Headquarters at austin, Texas, maintains a three inch by five inch locator card on all registrants with all boards located throughout the State of Texas and that these locator cards reveal that one LEE HAFVEY OSWALD, Selective Service Number 41-114-39-532, born October 18, 1939, is a registrant with Local Board Number 14, which is located at Fort Worth, Texas. This card contains no other information whatsoever concerning LEE HARVEY OSWALD and any information concerning him in the possession of the Selective Service System would be located in the files of Local Board Number 114, Fort Worth, Texas.

Mrs. DANNELLY further pointed out that the locator cards in the State Selective Service Headquarters indicates that there are fifteen individuals with the last name OSWALD in the locator files and that she recalls having searched for a name HARVEY OSWALD to these files when the individual known to her as HARVEY OSWALD contacted her on or about September 25, 1963, and finding no name listed therein for HARVEY OSWALD search for a LEE HARVEY OSWALD.

Mrs. DANNELLY further pointed out that she recalls that another employee of the State Selective Service Headquarters, namely Mr. JESSE E. SKRIVANEK, had brought HARVEY OSWALD back to her desk on the day in question which she thought to be September 25, 1963. She advised that she had checked and rechecked with JESSE E. SKRIVANEK who was on Christmas leave as of December 26, 1963, but that SKRIVANEK could not recall OSWALD by name and had made no notation concerning him at the time he came to State Selective Service Headquarters. She advised that as far as she knows Colohel SINCLAIR never at any time observed the individual using the name of HARVEY OSWALD and that JESSE E. SKRIVANEK is the only other employee that she can recall personally at this time who may have observed OSWALD.

Mrs. DANNELLY further pointed out that since she was last interviewed on December 19, 1963, she has since learned that the name of the printer whom she referred to

in previous interview was a Mr. L. B. DAY who is a printer for the Applia American Stateman, a daily newspaper published in American lexas. She likewise advised that she has learned that the name of the waitress in question whom she previously thought to be named FORDIE is actually Mrs. STELLA MORLAN, a vaitrous employed at the Trek Cafe, Austin, Texas. She states that she cannot at this time think of any other information of a pertinent nature concerning the visit of LEE MARVEY OSWALD. She cannot recall him having made any statement whathoever as to his mode of travel into or how he expected to depart from Austin, Texas, or his destination. The states that she has read a news item in the Texas Observer written by KONNIE DUGGER referred to in prior interview wherein DUGGER reported information reading as follows, "OSWALD had been in New Orleans last summer on September 23, 1963 Mrs. OSWALD and Mrs. RUTH PAINS of Irving drove to Irving and OSWALD left shortly thereafter.

"He turned up in Mexico City applying for travel papers to Russia fia Cuba on September 27, 1963. He could have stopped in Austin, Texas, on his way to Mexico through Laredo, Texas,"

Preferred to above apparently is information gathered by DUGGER minself and that she at no time ever furnished any such information to DUGGER. She stated that the information set out in the memorandum previously prepared for Special Agent H. T. BURK is the only information she had at the time of interview by DUGGER.

Lieutemant Colonel WILLIAM D. SINCLAIR, Chief of the Administrative Division, State Selective Service Readcultilers, Austin, Texas, advised that he had never heard of o s on TEE MALVE" OSWALD until his name was mentioned on numberst and television programs on November 22, 1963, in connection with the assassination of President RENNLDY. He at and further that on November 24, 1963, his Assistant Chact of the Administrative Division, Mrs. LEE DANNELLY, called him at home and advised him that after observing the photographs of OpWALD on television and hearing his name announced that she recalled that this individual had contacted her at State Selective Service Headquarters sometime in the past six or eight yeeks and that he had inquired at that time for infermation concerning a Marine corps discharge which he desired to have changed from "other than honorable" to an honorable discharge. Colonel SINCLAIR pointed out that at the time of this contact on November 24, 1963, Mcs. DANNELLY was ur to recall any specific date of this contact and that is old not appear to be pertinent at that time, but he advised this. DANAELLY that she should use her own discretion about whether or not the matter should be reported to the smoser authorities.

Colonel SINCLAIR was allowed to observe a photograph of LEE MARKEY OBMAID and be advised that he could not recall ever having seen that individual inside the State Selective Service Headquarters in Austin, Texas.

Colonel SINCLAIR further pointed out that there are a large number of callers at State Selective Service Headquarters and no register is maintained of the individuals who call at that office concerning routine matters which would have been the category of the inquiry referred to by Mars. DANNELLY on behalf of OSWALD.

SINCIAIN advised that he has no further information of any sort that would have any bearing upon where OSTAID actually did visit the State Selective Service Headquarters or whether he did not. He pointed out that there is always a possibility that the individual who contacted the state Selective Service Headquarters may have been an individual by the mane of OSWAID and been one other than LEE HALTY OSWAID, subject of this investigation.

Mr. RONNIE DUGGER, Editor, The Texas Observer, Austin Texas, newspaper, 504 W. 245h Street, advised he learned from Mrs. LEE DANNELLY, State Selective Service Headquarters, Austin, Texas, that she was contacted by a person believed to be identical with LEE HARVEY OSWALD on about September 25, 1963, at Austin, Texas. DUGGER feels Mrs. DANNELLY's information is reliable and that she is a very capable individual of good judgment.

In addition, DUGGER pointed out that he had interviewed Mrs. STELLA NORMAN, waitress at Trek Cafe, South Congress Avenue, Austin, Texas, who advised she had waited on a customer "about two months ago" who looked just like the pictures she had seen of LEE HARVEY OSWALD. She had reported the man believed to be OSWALD drank two or three cups of coffee and stayed at the cafe thirty or forty minutes and was alone. She further advised DUGGER that she had Wednesday off each week and the day she believes she saw OSWALD could not have been on September 25, 1963, since this date was on Wednesday.

DUGGER also had talked to L. B. DAY, a pressman for the American Statesman, Austin, Texas, newspaper. DAY claimed to have seen the man referred to by Mrs. NORMAN, and he also was convinced the man was identical with OSWALD.

DUGGER pointed out that while he feels the information furnished by Mrs. DANNELLY is reliable the information furnished by STELLA NORNAN and L. B. DAY is possibly a case of mistaken identity. His reason for this latter opinion was due to the statement of STELLA NORMAN that she did not work on Wednesday and Mrs. DANNELLY is positive the interview she had with the person believed to be OSWALD was on Wednesday.

CHAPMAN on 12/20/63 that two days apo, December 18, 1963, Mr. (First Name Unknown) GONZALES, Cuntoms Administrator, Higuel Aldenna, Maxico, stated that the FBI had been checking for information on OSVALD and that he (GONZALEZ) had found the information the FBI wanted concerning the re-entry at Miguel Alexan the same day OSWALD's brother who had entered Mexico at Miguel Aleman the same day GUMALD entered Mexico nt Laredo, Texas.

Mr. CONMALKE advised PURE that he was holding these records at his office in Miruel Alcoan.

The following investigation was conducted by SA CHRISTOPHER C. ISBELL.

On December 24, 1963, CARLOS RAMOS, Mexican Customs Administration and 1964E. ALMAN Mexico, stated that EDUARDO GONZALEZ, the customs administrator, would not return from Mexico City until January 2, 1964. RAMOS stated he had located the original copy of the Temporary Entry Permit showing the entry of ANTHONY W. OSSWALD into Mexico at that port of Entry on September 27, 1963. RAMOS and the other Smployee stated his was believed to be the information which GONZALEZ wanted to furnish the FBI.

It is to be noted that inquiry has previously been made concerning the entry into Mexico of ANTHONY W. OSSWALD.
