The trial of Jack Ruby was publicly aired, it was under the close scrutiny of the eyes of the world, it is reasonable to expect that numerous appellate procedures will be instituted for some time to come, and it is also reasonable to expect that this matter at some time will be judicially reviewed or at least submitted for such review to the Supreme Court of the United States.

Bea.ring in mind the above factors and the guidelines under which the FBI uses the polygraph, it would seem highly improper for the FBI to give favorable consideration to its use.

I wanted to bring the above facts to your attention in view of your request that the FBI make available its polygraph examiners in connection with the polygraph examination which you desire be afforded Jack Ruby.
