She said she does not recall any "blond show girl" or person in military service making the trip with her and her husband.

Mrs. BERKE said she has no recollection of GRRGS WILLIAM. FERRENBACH or anyone meeting his description as having worked for her father in Muncie. She said she knew FUILLIF JASSER as a close family friend. She said she also knew MORTON STANDT, a jeweler, as a business associate of her father. HERGERT and MORTON FAZOL are unknown to her. She said she had never been given any reason to question the loyalty of the above-nead persons and has no knowledge of cemmunist activities on their part.

BENJAMON J. KANTER, Attorney, 188 West Randolph Street, Chicago, Illinois, advised he had been a friend of IRMIN BERGE for many years in Chicago, prior to BERGE's moving to California.

KANTER recalled one occasion in 1946 or 1947 when he and his wite, rEGUT, planned to visit their son at Antioch College in Chio. BER E lestrated of their proposed trip and saked if KANTER could drop BERKE and his wife off at Muncie, Indians, on route to Ohio. KAITER and his wife visited with the BERKE and some unrecalled relatives at Muncie, Indians, for approximately one hour on this occasion. KANTER did not recall specifically the names of the relatives in Muncie, but believed they were in-laws of BERKE. He stated this was the only occasion he ever was in Muncie, Indians, with BERKE or in company with BERKE's relatives.

KANTER was not acquainted with Mrs. BERKE's sisters or other relatives. He stated he had no recollection of ever having known JACK RUBY or JACK RUBENSTEIN and his first knowledge of this individual came as a result of the murder of LEE HARVEY OSWALD.

FANTER advised BERKE was active in the masic publishing field in Chicago in the forties. He said BERKE loved to do card tricks and in other ways perform. He knew of no tall blond woman who might have accompanied BERKE to Muncis, Indians, or anywhere else. To the best of his knowledge, BERKE, his wife, and their acquaintances known to KANTER were not members of any subversive group and were believed by him to be loyal Americans.
