mman advised he arrived in dallan at approximately 7:30 PM, Novegber 22, 1963, He firat maw LBE HARVET OBWALD for Dallas Police Headquarterk. The only other time he gav OBWALD wan on 8unday morning, Novenber 24, when OSWALD wat shot and killed in the baeement of the Dallam police Headquartere by JACK RUBY. NETHAX laid he ne per interviewed oswald.

NETLAK related thet on November 24, 1983, he arrived at the pallag police geadquarters at approximately 10:30 AM. When he ontered police headquarters, he was required to identify himesif ac ontered police headquarters, he wat required to identimy hine the building, and be was again required to identify himielf. When he arrived in the balement he sav some 100 people gathered. He aitd bout hale wore uniformed police officera and he presued the othere bore plaitaiotheanen and menbert of the prefe, radio and TV.

MIMLAN atated OSWALD made hip appearance in the banement cecompaniad by two plainclotheamen, at approximately 11:25 AM. He gaid that in a aplit gecond JACI RUBY dashed out of the crowd and lired at oswalo. mEmLAN added that he had not noticed RUBY before this incident and overyone'a attention was on OSWALD an he made his appearance. RIMMAn atated that he did not get a good look at rivis as pointed out that he hal not until thie date soen RUBY'e face because the officery converged on mUBY as moon al he shot OSWALD.

He advieed that to the best of hia knowledge everyonc who ontered the basement of the Dallas Police Fendquartera on the norning of Novezber 24, 1963, waa required to identify himaelf, He added, in hie opinion the police officer did not look carefully at the dentification of minilin and other persons ontering the banoment. no was almo aurprised that thome entering the basemont vere not frimked" for meapone.

METMA maid that imediately after oswald was mot, the banoment vas in turmoil. Ho heard a unifored police officor, one
