IAROLD GORDON ALDENNAN. 6232 Delord Street, Tulane University Graduate Student, advised that in the past he has participated in Fair Play for Cuba activities in New York City, Washington, D. C., and Scattle, Washington. He said he has never been a member of the Fair Play for Cuba Committee but that during the approximate time of the Bay of PlgS Invasion he picked up literature from the Fair Play for Cuba Committee Office in New York City, and a lapel button with the words "Hands Off Cuba." Also, at the approximate time he participated in a picket line sponsored by the Fair Play for Cuba Committee in the area of of Central Intelligence Agency Office Building in Washington, D.C. Later, he was in a Fair Play for Cuba Committee picket line which picketed fimmer President JOIN F. KINNEDY in Seattle, Washington.

ALDERMAN said that he has engaged in no activity in New Orleans in furtherance of the kains. of the Fair Play for Cuba Committee, with the possible exception of the stand he took in a debate at Tulane University with writer ALEXANDER RORKE in October, 1962. He said that he is in sympathy with the aims of the Fair Play for Cuba Committee but was disappointed with the people who constituted the membership. He said that in the main, in fits opinion they are motivated emotionally rather than politically. He said he knows of no Fair Play for Cuba Committee organized activity in the New Orleans area, now or in the past.

ALDERMAN said that in the summer of 1963, possibly in July, 1963, a graduate student at Tulane, HUGH MURRAY, mentioned to him that he had picked up a Fair Play for Cuby Committee handbill being handed out on the Tulane campus, possibly in the library. ALDERMAN informed MURRAY that he would like to see the literature and later shortly thereafter, MURRAY gave it to him.

ALDERMAN said that he tacked the handbill on a door in his apartment and was surprised when the name A. J. HIDELL figured in the assassination of the late President KENNEDY. He said that this name, which he learned from the newspapers was an alias of LEE H. GSWALD, was stamped on the Fair Play for Cuba Committee literature which he had in his possession. Also, the address "P. O. Bor 30061, New Orleans, Louisiana".

ALDERMAN said that he did not follow up receipt of the literature with the contact of OSWALD and he knows no one who did. He said that he doubts that there is any organized Fair Play for Cuba Committee activity in New Orleans at this particular time He does not know JACK RUBY, LEK H. OSWALD, or O. H. LEE.

Lt. JANES RANDOLPH OSTALD, AF 70450A, 340th Bonb Squadron, Blytheville, Arknasz, Air Force Bane, advised SA DOWALD L. ANDERSON, of the Foderal Bureau of Investigation, and BERTRAW RASKIN, of the Office of Special Investigations (OSI), on May 21, 1964, that he is not related to LEE HARVET OSTALD. Lt. OSWALD advised that he was assigned in the Ballas - Fort Worth area during November of 1963 but that he had not taken a rille to the Irving Sport Shop, 221 East Irving Boulevard, Irving, Texas, to have a telescopic sight wounded. Lt. OSTALD further advised that he did not at that time nor does he presently own a first no tay type.
