

REPORTING EARNINGS

DISQUALIFICATION FOR FRAUD

All State laws provide legal penalties for alimants who obtain benefits fraudiciently, claimant who obtains benefits as a result of a false statement or representation, know-ing it to be false, or knowingly fails to dis-face a material fact, may receive an ad-sinistrative penalty by the Liable State of the prosecuted under the laws of Lew-land and the control of the control of the face.




